## Selection of Venues for Finals

There has probably been more contention regarding the selection of venues for the finals than around anything else. As a committee we have tried to spread the finals around between teams, taking into account the teams actually playing in the finals (and avoiding “home advantage” if there is any), proximity to the finalists, suitability of venues for particular finals, and some balance between Potters Bar/South Mimms and Barnet. Clearly this is not that easy and there have been some challenges to this approach in the past.

An alternative to the committee decision is outlined below.

We have 16 teams currently in the League and five venues available per year (MR Cup, Shield Final, Elleston, Singles and Pairs). The hosts for the five venues would be drawn from the 6 teams who did not host a final in the previous two years. The one remaining team would automatically get a final the next year (and the remaining four would be drawn from the 5 teams remaining). This would be drawn at the AGM. It would be up to the committee to allocate the five “winners” to the finals most appropriately.

## Singles/Pairs Finals Replacements

Because of illness or holidays, we have needed replacements in the past. We would like to formalize the process for replacement of the singles and pairs. Our proposals are

Singles	If a player is unable to appear in the final, the losing finalist from the appropriate heat to be invited.
Doubles – one player unavailable	If one player is unable to appear, a replacement can be used from the same team, ideally who has not played in the heats that year
Doubles – both players unavailable	If both players are not available, the losing finalists from the appropriate heat to be invited.

## Shield Competition

To engender greater competition within the Shield competition, we are proposing to have a semi-final with the winner of shield A playing the runners up in Shield B and vice versa (winners playing at home).

## Vice Presidents

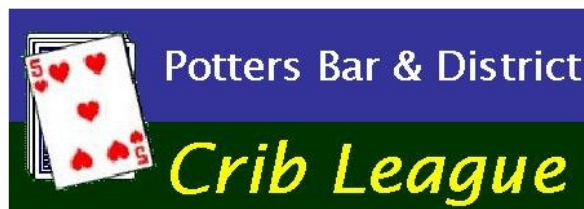

- a) League: 1<sup>st</sup> Division - 8 teams - play home and away in league (14 games)
- b) League: 2<sup>nd</sup> Division - 8 teams - play home and away in the league (14 games)
- c) Singles (Max 80 players. 8/12 at 8 venues with 8 winners going forward to final)
- d) Doubles (Max 64 pairs. 8 pairs at 8 venues with 8 winners going forward to final)
- e) Mike Russell Knockout Cup: 1<sup>st</sup> round, 2<sup>nd</sup> round, semi-final and final (4 weeks)
- f) Shields - 2 shields of 8 teams each playing each other once (7 weeks) winners and runners up to go forward to a semi-final final (1 week) . Winners to play off in a final (1 week)
